 - Jon Boniface discussed the permanent location as being at the future intersection of Hwy 9 and Devore Rd. While GDOT is working on Hwy 9 it will sit on pedestal on property east of Devore Rd.
 - There was clarification that the it is an original Henry Harvey art piece.
 - The sculpture is a cello.
 - It is meant to represent the importance of Arts & Music to the City of Alpharetta.
