Brijesh Brahmhatt of 4045 Weatherford Circle Alpharetta, GA 30009 is the owner, applicant and registered agent and was present on the call.

Mr. Brahmhatt stated he has been in the gas station and convenience store business for 17 years. This is a second location for him. He stated he is familiar with the City of Alpharetta's alcohol ordinances. They use a scanning system to check IDs. Mr. Stacy reminded him he is to obtain a separate alcohol license through the State of Georgia.

Michael Farrell, co-owner and residing at 433 Signal Hill Road North Barrington, IL 60010 was present on the call. Also on the call was Cassidy Farrell Cash residing at 9530 Rod Road Alpharetta, GA 30022 and is the registered agent. She is the head of the Customer Experience Department for Egg Harbor Café.

Ms. Cash stated they are now opening the 20th Egg Harbor Café location with 4 locations being in Georgia. She has experience with the process of alcohol serving at other locations. Ms. Cash confirmed the General Manager has stated staff at this location have gone through training on serving alcohol. Mr. Stacy reminded her servers will need to have a pouring permit. There was some question on whether there is a card issued or just a certificate of compliance. City Clerk Lauren Shapiro is going to reach out to City of Alpharetta Code Enforcement to clarify and reach out to Ms. Cash. Mr. Stacy also reminded her they will need to obtain a license from the State of Georgia.
