- Mr. Julio Delgado of 160 Douglas Fir Court, Alpharetta, GA 30022, is owner and registered agent of Fogon and Lions was on the call.
- Mr. Delgado stated this is his 2nd restaurant, the first being Minnie Olivia which is located in very close proximity to Fogon and Lions.
- Mr. Delgado stated he is familiar with the City of Alpharetta's alcohol ordinances and is aware he is required to obtain a State of Georgia alcohol license as well.
- Mr. Delgado stated his employees are TIPS certified trained in serving alcohol and that his employees serving alcohol are required to obtain pouring permits through the City of Alpharetta's Public Safety Department.
- Mr. Delgado plans to open the restaurant mid-to-late April 2022.

- Mr. Stacy recommended the application be approved. He advised the applicant that a representative will need to appear at the City Council meeting on Monday March 21, 2022 at 6:30 pm.

- Ms. Hanh Crose of 445 Northwood Cove, Alpharetta, GA 30009, is owner of July Moon Bakery & Cafe and was present on the call.
- Ms. Crose described the business as a primarily Asian bakery serving Asian sandwiches, baked goods, coffee and bubble tea.
- This is her first location and located in the new Maxwell development in Alpharetta and is already open for business.
- Ms. Crose stated she is familiar with the City of Alpharetta's alcohol ordinances.
- Employee training is provided using a downloaded alcohol manual. She is also aware her employees require a pouring permit to serve alcohol.
- Mr. Stacy reminded Ms. Crose she will need to obtain an alcohol license through the State of Georgia once she obtains the local license from Alpharetta.
- Mr. Stacy recommended the application be approved. He advised the applicant that a representative will need to appear at the City Council meeting on Monday March 21, 2022 at 6:30 pm.
