- Ms. Vania Mane, owner of the business and residing at 7420 Faith Street, Fairburn, GA 30213, was on the call.
- Ms. Mane stated this business was previously known as Gourmania, but has changed the name and concept of the restaurant. Gourmania did have an alcohol license that lapsed when it was not renewed by December 31, 2023.
- Ms. Mane stated the restaurant will close temporarily for renovations. They will reopen with a new menu.

- Ms. Mane stated they currently have one employee, but anticipate having four employees. She understands employees will need a pouring permit if handling alcohol orders and sales. Ms. Mane stated she has a pouring permit.
- Officer O'Donnell confirmed that City staff has reviewed the application and that it meets all the City's requirements for an alcohol license. Ms. Shapiro recommended the application be approved and advised the applicant that a representative will need to appear in person at the Alpharetta City Council meeting on Monday, March 4, 2024, at 6:30 pm in case Mayor or Council have any questions.
